ADVISORY 45 ON THE 2019 NOVEL CORONAVIRUS

The Philippine Consulate General informs all Filipinos and Filipino-Americans in **Southern California, Southern Nevada and State of Arizona** of the following CoViD-19 Developments:

California

Southern California remains under the Regional Stay-at-Home Order policy having a sustained 0% I.C.U. capacity.

California's **Travel Advisory**, which is initially announced through Advisory 43 dated 20 November 2021, has been expanded with highlights as follows:

- Californians should **avoid non-essential travel to any part of California more than 120 miles from one's place of residence**, or to other states or countries;
- **Non-essential travelers from other states or countries are strongly discouraged from entering California, and should adhere to the quarantine procedures;** and
- All persons arriving in or returning to California from other states or countries, should **self-quarantine for 10 days after arrival, except as necessary to meet urgent critical healthcare.**

Travel restrictions in the Philippines

In view of the continued surge of CoViD-19 infections and emergence of new CoViD-19 variant, **Filipino nationals are advised to consider postponing their travel plans to the country.**

Foreign nationals, who have visited countries with reported new CoViD-19 variant, including the United States of America, in the last 14 days shall not be allowed to enter the Philippines until 31 January 2021. The Philippine Government continues to update travel restrictions depending on the pandemic situation in the Philippines.
