



## ADVISORY 32 ON THE 2019 NOVEL CORONAVIRUS DISEASE (COVID-19)

### COVID-19 cases in Southern California, Southern Nevada, and Arizona (as of 10 May 2020)

- **Southern California:** 52,016 COVID-19 cases with 2,158 deaths
- **Southern Nevada:** 4,750 COVID-19 cases with 260 deaths
- **State of Arizona:** 11,119 COVID-19 cases with 536 deaths

### REOPENING OF NINOY AQUINO INTERNATIONAL AIRPORT

Inbound commercial flights carrying passengers will now be allowed to land at the Ninoy Aquino International Airport (NAIA) starting 11 May 2020 in the following schedule according to the Civil Aviation Authority of the Philippines (CAAP):

#### 1. Mondays and Thursdays

Inbound international chartered flights provided that endorsement from the Department of Foreign Affairs and clearance from CAAP are secured

#### 2. Tuesdays, Wednesdays, Fridays, Saturdays, Sundays

Inbound international commercial passenger flights provided that CAAP approval is secured 48 hours prior to departure from the airport of origin.

The above restrictions will be implemented from **11 May 2020 to 10 June 2020 at NAIA only**. Other international airports in the Philippines have separate restrictions.

The above restrictions do not apply to the following: en route flights experiencing emergencies; cargo flights; air ambulance and medical supplies flights; government and military flights; weather mitigation flights; and maintenance and utility flights.

The traveling public is reminded that, under health protocols issued by the Philippine Government issued on 11 May 2020:

1. **All passengers** arriving in the Philippines are required to undergo **COVID-19 RT-PCR** test;
2. **All passengers** are required to undergo **quarantine** procedures in approved facilities while awaiting the result of their test;
3. Payment for accommodation in the approved quarantine facilities will be in accordance with the following:
  - a. For **returning OFWs** – payment shall be shouldered by the **Overseas Workers Welfare Administration** for land-based OFWs, and by the **local manning agency and/or the Maritime Industry Authority** for sea-based OFWs;
  - b. For non-OFWs – payment will be **at their own cost** and based on their own choice of quarantine facility.
4. All disembarking crewmembers are subject to the same testing procedure and quarantine protocols;
5. Arriving passengers are encouraged to fill in the **Case Investigation Form** prior to arrival at NAIA. The form can be downloaded from <http://ritm.gov.ph/wp-content/uploads/2020/03/COVID-19-Form-1.pdf>.

**Passengers should expect delays upon arriving at NAIA. Non-essential travel is still discouraged.**
